Requirements:

EITHER

- Person of distinct learning and made significant contribution to the Banking and financial Services industry

- No CPDs required

OR

- Financial Institutions Board Members, Bank Executive Directors and Bank CEOs / MDs.
- Nominated by the UBA or 2 UIBFS Fellows and elected by the Council
- Required to take 20 CPDs (hrs) or undertake knowledge sharing through facilitating the CPD program, contribution in publications, research, structured coaching and mentoring
